 6. Cane for CCS Judging is to be presented as 6 sticks in any one (1) recommended variety - 1.4 metres with tops removed

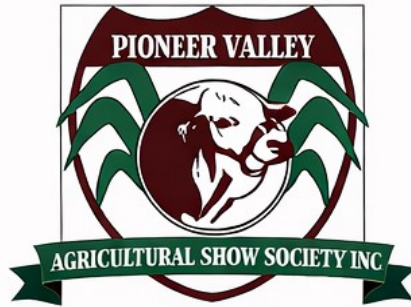
